#### Inclusive and Innovative Multigenerational Communities in Isolated Areas of Australia

This project will spotlight settings in rural and remote island communities encompassing a range of marginalised individuals, including Aboriginal and Torres Strait Islanders and Forgotten Australians. Underpinned by support from Local, State and Federal Governments, economic development initiatives, peak body associations, aged and community care service providers, technology vendors and community leaders, this project will explore opportunities for innovative and digitally enhanced solutions to promote multigenerational inclusive living in isolated communities.

# Smart & Healthy Ageing through People Engaging in Supportive Systems (SHAPES)

SHAPES aims to create an open ecosystem enabling the large-scale deployment of digital solutions for healthy and independent living, addressed to older individuals who face reduced functionality and capabilities. Funded by the European Commission under Horizon 2020, AAA is one of 36 partners sharing a €21m 4 year research grant, involving more than 2000 older adults across 15 pilot sites.

Operating at the core of Europe's largest housing association, 'Clarion Futures' is delivering one of the UK's largest social investment programmes, investing £150 million over 10 years to provide the tools and support people need to transform their lives and communities for the better.

Clarion's Regeneration team are currently identifying suitable sites to construct "no fuss" mixed tenure neighbourhoods, where young and old, disabled and able, can co-exist in well-designed technologically enabled housing, with access to bespoke services to help facilitate independent living and enhance wellbeing.

## 4.00PM SMART MULTIGENERATIONAL NEIGHBOURHOODS PILOT 4 USA

**Joy Melnikow,** Director of the University of California, Davis, Center for Health Policy Research together with **Chrysa Demos,** President and CEO, AKT Development Corporation and Bear River Land Holdings, LLC.

University California Davis (UCD) and Bear River Land Holdings, LLC (BRL) have joined forces to establish The Community for Health and Independence (CHI), a planned, health-focused, community open to all but supportive of older adults; individuals with disabilities and other vulnerable populations.

BRL has allocated 2,000 acres of undeveloped land near Sacramento in California building 500-700 homes in the initial development phase with a full build-out of 4,000-6,000 units with retail (i.e., grocery and drug stores), parks, walking trails, nature conservancy sites, and facilities to promote socialization, exercise and recreation.
